Thanks for your application!

If handing in your application in person, you may have had a brief job interview.

Just so you know, from here:

- 1. Nikau will make all efforts to contact all applicants of their status for a job position, however this sometimes is not practicable
- 2. A Nikau representative will contact you within **1 week** should you be shortlisted for the position
- 3. If you are shortlisted, you will receive a letter (by email) with:
 - a. Invitation for an interview
 - b. Address / date / time for pre-employment medical
 - c. Address / date / time for drug and alcohol test
 - d. Items (b) and (c) are normally conducted at the same provider
 - e. Ministry of Justice Third Party Criminal Convictions Third Party (TPCCC) consent form. This must be completed and returned within **2 days** of receipt to the writer of the email
 - f. Should the appointment times schedule for the items (b) and (c) be unsuitable you need to contact the writer of the email as soon as possible to reschedule
- 4. At the interview it is recommended that you bring any further information, proof of experience etc. with you.
- 5. If you are successful in your application you will receive a job offer pack that will contain:
 - a. A letter of offer
 - b. Employment contract
 - c. Employee handbook
- 6. Nikau may give a job offer conditional on Nikau receiving a satisfactory criminal record check
